PARENT OR GUARDIAN PERMISSION FOR PRIVATE VEHICLE TRANSPORTATION FOR THE 2007/2008 SCHOOL YEAR FFA

Your son/daughter is participating in FFA in the Mt. Baker School District. If the student elects to participate in the, FFA, then he/she may elect, **IF PERMISSION IS GRANTED BY THE PARENT OR GUARDIAN**, to use private transportation to and from FFA activities including, but not limited to, trap shoots, jamborees, District leadership and log rodeos. In such cases, the advisor will instruct the student who is driving as to the general route to and from the assigned destination; require written assurance from the student and parent that he/she has a valid Washington State driver's license; a current liability insurance policy with minimum limits of \$100,000/\$300,000; and parent's or guardian's permission (see below). Should questions arise, parents or students are urged to talk with the advisor.

If your son/daughter will at any time be utilizing (driving or riding) private transportation, the following must be completed.

Failure to initial one or more of the above constitutes a denial of permission of travel by the means **NOT** initialled.

The Mt. Baker School District assumes no responsibility for the private transportation to FFA practices or competitions which are held at sites off the Mt. Baker campus. As the parent or guardian of the above-named student, I/we release Mt. Baker School District from any and all claims, damages or action which may arise out of an accident or injury resulting from the voluntary transportation utilized to attend FFA activities or competitions off the Mt. Baker campus. I/We further agree to indemnify and hold harmless the Mt. Baker School District from any and all claims, demands, or actions for damages or injury to person or property from the occurrence of any such accident.

If I/we have initialed above that our son/daughter will be driving an automobile, we are assuring the Mt. Baker School District (by evidence of our signature below) that our son/daughter possesses a current and valid Washington State driver's license and we/he/she are/is insured to the above mentioned limit. I/We also accept responsibility of monitoring which students our daughter is transporting or is riding with (by evidence of our signature below).
